READ CAREFULLY - WAIVER AND
RELEASE OF LIABILITY

In consideration of SC Family Fun LLC furnishing equipment to enable me to
participate in kayaking, canoeing, fishing, sailing or other types of boating (hereinafter
“boating”), I acknowledge that I am over 18-years-old and agree for myself and anyone I
allow to use this equipment as follows:

I acknowledgement that boating can be dangerous: I fully understand and
acknowledge that: (a) outdoor recreational activities have inherent risks, dangers and
hazards and such exist in my use of boating equipment and my participation in boating
activities; (b) my participation in such activities and/or use of such equipment or premises
may result in injury or illness including, but not limited to bodily injury, disease, strains,
fractures, partial and/or total paralysis, death or other ailments that could cause serious
disability. Risks and dangers may arise from foreseeable or unforeseeable causes
including risk of falling out of or drowning while in a boat and such other risks, hazards
and dangers that are integral to recreational activities that take place in an outdoor or
recreational environment.

I assume all risks, dangers and responsibilities: By my participation in these activities
and/or use of this equipment, I hereby assume all risks and dangers and all responsibility
for any losses and/or damages, whether caused in whole or in part by negligence or other
conduct by myself or by any other person. I also verify that I and anyone I allow to use
this equipment are in good health and do not suffer from any physical impairments
limiting engagement in boating activities, and are capable of pursuing the sport of
boating. I also verify that I and anyone I allow to use this equipment will not be under
the influence of any drugs or alcohol of any kind while boating. I also agree to wear a
properly secured USCG approved personal floatation device, of type 3 or better, at all
times. I understand SC Family Fun LLC does not allow its boats on the open ocean or in
fast moving or white water rivers or streams.

I will release and hold harmless: I, on behalf of myself, my personal representatives
and my heirs, hereby voluntarily agree to release, discharge, hold harmless, defend and
indemnify SC Family Fun LLC and its owners, agents, officers and employees from any
and all claims, actions or losses for bodily injury, property damage, wrongful death, loss
of services or otherwise that I may have suffered during my participation in boating
activities, including for the negligent acts or other conduct in the present time or in the
future by the owners, agents, officers or employees of SC Family Fun LLC. I further
release and hold harmless SC Family Fun LLC for any medical arrangements or care
provided to myself or others I allow to use this equipment). I understand and
acknowledge that SC Family Fun LLC carries no liability or accident insurance.

I will take care of this equipment and return it on time: I agree that I and anyone I
allow to use this equipment will treat this equipment with care and return it clean and in
the same condition as received (minor scratches are acceptable). I agree to repair or
replace any equipment lost or damaged while under my control and/or to pay additional
fees if I do not return this equipment clean or by the expected return date. I authorize you
